Procedures

1. 申請方式

1. How to Apply

All registrations must be made by correspondence, and 10 copies of the submitted materials for review must be submitted by registered mail to Taiwan Health Food Society.

2. 送審資料

- (1) 申請書（公司基本資料、參選產品資料及研發創新事實說明書、及加入本會之團體會員證明資料）。
- (2) 研發和品保(或品管)部門(須附相關人員簡歷與設備簡介)。
- (3) 公司執照影本。
- (4) 營利事業登記證影本。
- (5) 前一年營利事業所得稅結算申報書影本。
- (6) 產品樣本及其他有關申請獎勵標的之相關證明文件影本、圖面資料、相片、型錄等。
- (7) 參選報名時每件請同時繳交費用貳萬元整。

2. Submit Information for Review

- (1) Application form (including basic company information, participating product information and R&D innovation fact sheet, along with proof of group membership information.)

(2) R&D and quality assurance (for quality control) departments (relevant personnel resumes and equipment introduction must be attached).

(3) A copy of company license.

(4) A copy of the registration certification of the profit-making enterprise.

(5). A copy of the profit making enterprise income tax settlement declaration of the previous year.

(6) Copies of product samples and other relevant supporting documents, drawings, photos, catalogues relating to the subject of the award application.

(7) When registering for this award entry, please pay a fee of 20,000 NTD for each application.

3. 評審標準：基本評審項目及權重

- (1) 申請獎勵標的之研發創新性 (70%)。
- (2) 申請獎勵標的之品質管控及產製特色 (20%)。
- (3) 申請獎勵標的之國際競爭力或代表性 (10%)。
- (4) 當申請標的之評審積分相若時，以未曾獲本會獎勵之企業優先考慮，惟仍由評審委員會議決之。

3.Evaluation criteria : Basic evaluation categories and percentages

(1) R&D innovation of the subject of application for award. (70%)

(2) The quality control and production characteristics of the subject of application for award. (20%)

(3) The international competitiveness of the subject of the application for award. (10%)

- (4) When the evaluation points of the application targets are similar, the enterprises that have not received awards from our organization will be given priority, but the decision will still be made by the evaluation committee.
